What Personal Data We Collect

We may collect the following types of personal data:

- Contact details: name, email address, phone number, company name, job title, postal address
- Account information: login credentials, preferences
- Service interaction data: your responses to surveys, questionnaires, or research projects
- Usage data: IP address, browser type, device information, pages visited, time spent on pages
- **Social login data**: if you register via Google, Facebook, or other platforms, we may access basic profile information (name, email, profile picture) with your permission

We only collect the data necessary for the purposes explained below.

How We Use Your Personal Data

We process your personal data for the following purposes:

- To provide and maintain our services to manage your account, deliver content, and improve our offerings
- To communicate with you to send updates, respond to your requests, or inform you about service changes

- To send marketing communications only if you have consented or if we rely on legitimate interest (you can opt out at any time)
- To conduct research and benchmarking data for research projects will only be reported in aggregated form unless you give explicit consent for individual-level use
- To comply with legal obligations for example, record keeping for tax or regulatory requirements
- To improve security and analytics to detect fraud, ensure the security of our services, and understand usage trends

Legal Basis for Processing

We process your personal data under one or more of the following legal bases:

- Contract when processing is necessary to provide our services you requested
- Consent for sending marketing communications or using non-essential cookies
- Legitimate interest for improving our services and ensuring network and information security
- Legal obligation when required to comply with the law

You can withdraw your consent at any time by contacting us or using unsubscribe options in our emails.

How Long We Keep Your Data

We only keep your personal data for as long as needed for the purposes described above:

- · Contact details for marketing purposes: until you withdraw consent or unsubscribe
- Account and service data: for the duration of your relationship with us plus 7 years after account closure for legal or contractual claims
- Research data: retained in aggregated or anonymised form where possible
- Usage logs: retained for a short period for security and analytics unless longer retention is required by law

When data is no longer needed, we securely delete or anonymise it.

We do **not sell** your personal data.
